CONTINUING EDUCATION

The Connecticut Real Estate Commission has approved one Mandatory Continuing Education Course for the 2010-2012 Cycle. Both brokers and salespersons have the same 12-hour C.E. Requirements. The following class is REQUIRED by law: "CT Real Estate Agent Fiduciary Duties Review and Law Update".

By law, the other 3 courses are electives, however if you are a REALTOR®, you are required by the NATIONAL ASSOCIATION OF REALTORS® to complete a 3-hour course on the REALTORS® CODE OF ETHICS by December 31, 2012 in order to renew your REALTOR® membership on January 1, 2013. Your Local Association retains records for this requirement for each member.
