REGISTRATION POLICY

A completed Registration Form must be submitted *with payment* at the time of registration. Check or credit card payments are accepted. All FAXED or E-MAILED registrations must be paid by credit card. MC/VISA or American Express credit cards are accepted. The School will not be required to provide class confirmation, unless a selected course is full or canceled due to lack of attendance. For P & P courses, the class minimum is 15 and class maximum is 25.

CANCELLATIONS
